## Keep Ohio Beautiful Paint Grant Application

Keep Ohio Beautiful Painting Grant is a program designed to provide community groups with paint and painting supplies enabling them to renew a community structure in need into something beautiful through the application of fresh paint and a lot of elbow grease.

### Grant Criteria

The grant is available to all Keep Ohio Beautiful Affiliates in good standing with Keep America Beautiful. Private property owners or individual applicants cannot apply.

Each application is eligible for up to 40 gallons of exterior paint provided by The Sherwin-Williams Company, and five (5) grants will be awarded.

Only one building per application is allowed. Applicants can submit multiple applications.

Applicants must provide proof of liability insurance. The use of a volunteer waiver form is highly encouraged, but not mandatory. Samples are available.

Applicants must provide signed permission to paint from the property owner prior to the distribution of any grant funds. Award letters are valid pending signed permission. A permission to paint form is available in your packet and to download from our website at [www.keepohbeautiful.org](http://www.keepohbeautiful.org). Click on Beautiful Communities Tab and scroll down to Paint Grant Program.

Applicants are required to submit at least two (2) before photos of their intended project. Photos must clearly show the relative size of the building, condition of neglect, structure in relation to its surroundings, and more than one angle.

Applicants must adhere to up to a 40 gallon limit of exterior paint. Applicants may choose their own paint colors; however, chosen colors cannot be in violation of any local ordinances or zoning laws. Applicants will work with a Sherwin-Williams consultant to suggest colors for the structure, prep-work, and if needed, suggestions of supplies and materials.

Applications must be received by April 1, 2020. All applications will be evaluated by a review committee and awarded May 1, 2020.

Projects kick-off on June 1 and will continue through October 1, 2020.

At the conclusion of the project, a completed final report including during and after photos, supply receipts, volunteer totals, donation information (if any), media coverage, community response, and a personal story of the day must be submitted by November 1, 2020. Photos are required.
